1 WHEREAS, on December 20, 2016, the Court entered an order (the "Final Approval Order")
2 granting final approval of the settlement of this action, the terms of which are embodied in the Joint
3 Stipulation and Class and PAGA Action Settlement (the "Settlement"), finding that the settlement is
4 fair, adequate, and reasonable:

5 This Court hereby enters final judgment in this case, in accordance with the terms of the
6 Settlement, as incorporated by reference by the Final Approval Order. The Court hereby permanently
7 enjoins and restrains all individuals who did not timely exclude themselves from asserting any and all
8 claims that were released pursuant to the Agreement and the Final Approval Order.

9 Without affecting the finality of this Judgment in any way, the Court reserves exclusive and
10 continuing jurisdiction over this action, the Class Representatives, the Settlement Class, and the
11 Defendant (as those terms are defined in the Agreement) for the purposes of supervising the
12 implementation, enforcement, construction and interpretation of the Settlement, the Preliminary
13 Approval Order, the Final Approval Order, and this final Judgment and the distribution of Settlement
14 payments and tax forms.

15 **IT IS SO ORDERED AND ADJUDGED. LET JUDGMENT BE FORTHWITH**
16 **ENTERED ACCORDINGLY.**
